



TOURISM VISA (VISITING FAMILY OR FRIENDS) CHECKLIST

The application must be submitted at least 15 days before the intended travel date. Failing to do so will result in the application to be returned.

1	<input type="checkbox"/>	Application form duly completed and signed.
2	<input type="checkbox"/>	One passport size color photo, white background, maximum 6 months old (see specifications);
3	<input type="checkbox"/>	A valid passport (and a copy) satisfying the following criteria: <ul style="list-style-type: none">○ its validity must be at least three months longer than the visa requested;○ it must contain at least two blank pages;○ it must have been issued within the previous 10 years;○ it must hold a valid UAE visa. Damaged passports will not be accepted.
4	<input type="checkbox"/>	Copy of UAE Residence Visa valid at least 90 days from the intended return date.
5	<input type="checkbox"/>	Previous Schengen, USA, or UK visa copy.
6	<input type="checkbox"/>	No Objection Certificate from local sponsor/employer mentioning: <ul style="list-style-type: none">○ Name and designation of the applicant;○ Start of employment date;○ Applicant's monthly salary;○ No objection to travel to Italy;○ Duration of leave and exact date of resuming of duty;○ Name and designation of the managerial signatory;○ Direct phone number and e-mail of the signatory;○ Provide copy of passport and UAE visa of the signatory.
7	<input type="checkbox"/>	Employment Labor Contract / agreement.
8	<input type="checkbox"/>	Copy of a valid trade license.
9	<input type="checkbox"/>	Verifiable evidence of sufficient means of subsistence during intended stay: <ul style="list-style-type: none">○ Last 3 months pay slips;○ Last 3 months bank statements (foreign bank accounts will not be considered);○ A valid international credit card accompanied by the relevant last 3 months card statements;○ Any other document that might help evaluate your financial situation in the UAE (i.e. other bank accounts, personal properties, investments, etc...). Bank Statement should be on a bank letterhead. Photocopies or online statements must bear the original bank stamp.
10	<input type="checkbox"/>	An international medical insurance covering the entire stay with a minimum of 30.000 € coverage and full and unlimited coverage for hospitalization. Emergency repatriation flight as well as repatriation of mortal remains must be included. Detailed table of benefit must be provided.
11	<input type="checkbox"/>	Letter of invitation from the Italian friend/partner or family member. The invitee must be legally resident and present in Italy and must accommodate the applicant in his own private accommodation.
12	<input type="checkbox"/>	Self declaration form for entering Italy from abroad duly filled and signed. The form can be downloaded from the Italian MOFAIC web site together with any other proof of the relationship with the Italian citizen.
13	<input type="checkbox"/>	Confirmed direct flight booking. During the Pandemic we strongly advise the applicant to book a direct flight in order to avoid any problems due to the possible implementation of additional access restrictions in the transiting Countries.

14	<input type="checkbox"/>	<p>If the applicant is a minor:</p> <ul style="list-style-type: none">○ A copy of both parents' (or legal guardians) passports;○ N.O.C.: Consent letter mentioning purpose of the trip, destination, exact dates. Letter must be signed by both parents/legal guardians directly at our Visa Application Center. If one of the parents is abroad, he/she will be asked by the Consulate to contact the nearest Italian Consulate/Embassy in order to sign the consent letter in front of an officer;○ Birth certificate: No birth certificate is required if the full name of both parents/legal guardians are mentioned (in English) in the applicant's passport; If not, an original or certified copy of the birth certificate (translated in Italian or English), duly legalized by the Italian Embassy/Consulate in the Country where the document has been issued, must be provided;○ Divorced parents: Original/legalized copy of the divorce sentence with clear mention of full custody (translated in Italian or English); <p>Originals and/or certified copies will be returned if a copy is provided.</p>
