Damaged passports will not be accepted.					
4		Copy of UAE Residence Visa valid at least 90 days from the intended return date.					
5		Previous Schengen, USA, or UK visa copy.					
6		No Objection Certificate from local sponsor/employer mentioning: Name and designation of the applicant; Start of employment date; Applicant's monthly salary; No objection to travel to Italy; Duration of leave and exact date of resuming of duty; Name and designation of the managerial signatory; Direct phone number and e-mail of the signatory.					
7		Employment Labor Contract / agreement.					
8		Copy of a valid trade license.					
9		 Verifiable evidence of sufficient means of subsistence during intended stay: Last 3 months pay slips; Last 3 months bank statements (foreign bank accounts will not be considered); Last 3 months credit card statements; Any other document that might help evaluate your financial situation in the UAE (i.e. other bank accounts, personal properties, investments, etc). Bank Statement should be on a bank letterhead. Photocopies or online statements must bear the original bank stamp. 					
10		An international medical insurance covering the entire stay with a minimum of 30.000 € coverage and full and unlimited coverage for hospitalization. Emergency repatriation flight as well as repatriation of mortal remains must be included. Detailed table of benefit must be provided.

- N.O.C.: Consent letter mentioning purpose of the trip, destination, exact dates. Letter must be signed by both parents/legal guardians directly at our Visa Application Center. If one of the parents is abroad, he/she will be asked by the Consulate to contact the nearest Italian Consulate/Embassy in order to sign the consent letter in front of an officer;
- o Birth certificate: No birth certificate is required if the full name of both parents/legal guardians are mentioned (in English) in the applicant's passport; If not, an original or certified copy of the birth certificate (translated in Italian or English), duly legalized by the Italian Embassy/Consulate in the Country where the document has been issued, must be provided;
- Divorced parents: Original/legalized copy of the divorce sentence with clear mention of full custody (translated in Italian or English);

Originals and/or certified copies will be returned if a copy is provided.

I understand that an application without a complete set of documents may result in the refusal of my visa application. The submission of a complete file does not guarantee the issuance of a visa. The passport will not be returned until the final decision on the visa is adopted. The Consulate General reserves the right to ask for a Personal Interview or any additional documents.
